I hereby request the certified copies of the following information, documents, and communications:

Certified copies of all correspondence, including emails, letters, memorandums, or any other written or electronic communication exchanged between the Kurla Police Traffic Department and any other relevant departments or individuals concerning my complaint regarding the non-compliance with the court order issued in PIL No. 113 of 2022.

2. Certified copies of any internal memos, notices, circulars, directives, or orders issued by the Kurla Police Traffic Department concerning the court order issued in PIL No. 113 of 2022, specifically related to the prohibition of auto rickshaw and taxi drivers from refusing passengers on jurisdictional grounds.

3. Detailed records of all actions taken by the Kurla Police Traffic Department in response to my aforementioned complaint, including, but not limited to, investigations conducted, identification of the drivers involved in instances of refusal, legal proceedings initiated against said drivers, and any other relevant actions undertaken to enforce compliance with the court order.

4. Any records, documents, or reports related to awareness campaigns or sensitization programs conducted by the Kurla Police Traffic Department to ensure the compliance of auto rickshaw and taxi drivers with the law and their responsibilities towards passengers, as outlined in PIL No. 113 of 2022.

5. A certified copy of the receipt or acknowledgment of my initial complaint email, dated Tuesday, May 30, 2023 at 8:24 PM, sent from my email address (asifkhan.dell@gmail.com) to kurla.traffic@mahapolice.gov.in, as evidence of the submission of my complaint.

If this request does not fall within the jurisdiction of your department as defined under the Right to Information Act, 2005, specifically Section 6(3), I kindly request that you transfer it to the relevant department as per the provisions of the law. I further request that you provide a written notification to me regarding the transfer of my request, specifying the name and contact details of the department to which it has been forwarded.

I kindly request that the certified copies of the above-mentioned information be provided to me in accordance with the provisions of the Right to Information Act, 2005. I am willing to pay any applicable fees required for obtaining the requested information, as prescribed under the Act.

I request that the certified copies be provided to me within the time frame stipulated under Section 7(1) of the Act. If any information requested is deemed exempted under the provisions of the Act, I request that the specific sections and grounds for exemption be clearly stated in writing.

Furthermore, I kindly request that the requested information be provided to me in both hard copy and electronic format. This will allow me to maintain a physical record of the information, as well as have a copy that I can easily access and share.

Please acknowledge the receipt of this request and provide me with the necessary information on how to proceed with the payment of fees, if applicable. Furthermore, I kindly request that all correspondence and communication related to this request be directed to my email address provided above.

Please treat this request as an urgent matter, considering the importance of obtaining the requested information in a timely manner. I trust that the Public Information Officer will fulfill their obligations under the Act and facilitate the dissemination of the requested information.
